## Special and/or sensitive personal data that we process

Camping Vive La Vie does not process any special and/or sensitive personal data about you. Our website and/or service does not intend to collect data about website visitors who are under 16 years of age. Unless they have permission from parents or guardians. However, we cannot verify that a visitor is over the age of 16. We encourage parents to be involved in their children's online activities in order to prevent the collection of information about children without parental consent. ## For what purpose and on what basis do we process personal data?

Camping Vive La Vie processes your personal data for the following purposes:

- Handling your payment
- To be able to call or e-mail you if this is necessary to be able to perform our services
- Processing your reservation
- Camping Vive La Vie also processes personal data if we are legally obliged to do so, such as data that we need for our tax return



### How long we keep personal data

Camping Vive La Vie does not store your personal data any longer than is strictly necessary to achieve the purposes for which your data is collected.

### Sharing personal data with third parties

Camping Vive La Vie only provides information to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

### Cookies, or similar techniques, that we use

Camping Vive La Vie only uses technical, functional and analytical cookies that do not infringe on your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and remember, for example, your preferred settings. It also allows us to optimize our website. You can opt-out of cookies by setting your internet browser to stop storing cookies. In addition, you can also delete all information that has been previously stored through your browser's settings.

### Google Analytics

In cases where we have activated the Google Analytics tool, cookies from the American company Google are placed via our website as part of the Analytics service. We use this service to monitor and receive reports on how visitors use the website. This tool is set up in a privacy-friendly way. For example, we have not allowed Google to use the obtained Analytics information for other Google services, we have the IP addresses pseudonymized and have entered into a processing agreement with Google.

The information collected by Google is transferred to and stored on servers in the United States. Google states that it adheres to the Privacy Shield principles and is affiliated with the Privacy Shield program of the U.S. Department of Commerce. This means that there is an appropriate level of protection for the processing of any personal data.

By using this website, you consent to the processing of your information by Google in the manner and for the purposes described above.

To ensure that the request for access has been made by you, we ask you to send a copy of your proof of identity with the request. In this copy, black out your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN). This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.
